## Vidhi Parivartan presents Law Fest 2025 – Legal Drafting Competition

### **ABOUT THE COMPETITION**

Legal drafting is the soul of advocacy and litigation. To refine the art of structured legal writing and argument formulation, **Vidhi Parivartan** is pleased to announce the **National Legal Drafting Competition**, **2025**. This initiative is aimed at providing a platform for budding and experienced legal professionals to demonstrate their drafting prowess in **civil**, **criminal**, and **matrimonial** domains.

### **ELIGIBILITY**

- Open to all.
- All Law Students (UG & PG), Advocates (Enrolled with Bar Council), Academicians (Law Teachers, Researchers) are eligible to participate in this competition.
- Only one submission per author(s) will be accepted. Multiple or incomplete submissions will lead to disqualification.

## DRAFTING CATEGORY OPTIONS (CHOOSE ANY ONE)

### 1. Civil Law Proposition

#### **Facts:**

Ms. Riya Sharma, a resident of Delhi, lent a sum of Rs. 2,00,000 to her friend Mr. Aditya Khanna on 10th January 2024 for the purpose of his business expansion. The amount was transferred through a bank account, and Aditya promised to return it within six months.

Despite several oral reminders and a legal notice dated 25th August 2024, Aditya has failed to repay the amount. He has neither denied the loan nor shown any willingness to return the money. Riya now wishes to file a civil suit for recovery of Rs. 2,00,000 along with interest @12% per annum before the appropriate court.

### Participants' Task:

Draft a Plaint on behalf of the Plaintiff (Riya Sharma) for filing before the Civil Judge (Junior Division).

2. Criminal Law Proposition

**Facts:** 

Rohit Verma, a 24-year-old student, has been arrested by the local police on 15th August

2025 under Section 379 IPC for alleged theft of a mobile phone from a shopping complex in

Bhopal. The police have seized a mobile phone, but the ownership of the same is disputed.

Rohit claims he found the phone lying unattended and was about to deposit it at the nearby

security desk when he was apprehended. He has no previous criminal record, is a permanent

resident of Bhopal, and undertakes to cooperate with the investigation. The charge sheet has

not yet been filed.

**Participants' Task:** 

Draft a Bail Application under Section 437 Cr.P.C. on behalf of the accused, Rohit Verma,

before the learned Judicial Magistrate First Class, Bhopal.

3. Family Law Proposition

**Facts:** 

Mrs. Sneha Kapoor and Mr. Aman Kapoor were married on 12th February 2020 according to

Hindu rites and ceremonies in Chandigarh. They lived together peacefully for about two

years.

However, due to frequent misunderstandings and interference from Aman's parents, Sneha

was allegedly asked to leave the matrimonial home in March 2023. Since then, Aman has

neither contacted her nor made any effort to bring her back. Sneha is still willing to live with

her husband and wishes to resume her marital life.

**Participants' Task:** 

Draft a Petition under Section 9 of the Hindu Marriage Act, 1955 on behalf of the wife

(Petitioner) for Restitution of Conjugal Rights before the Family Court at Chandigarh.
